NONPARTISAN GENERAL ELECTION**

Election Date: **JUNE 9, 2020**

REGISTRATION DEADLINE: MAY 11, 2020

Prior to Election Day: confirm your registration and poll location by calling Voter Registration at **(912) 790-1520** or use the **MY VOTER PAGE** website at **www.mvp.sos.ga.gov**. Keep your residence and mailing address updated with the Voter Registration Office.

ABSENTEE VOTING BY MAIL:

APRIL 21, 2020 – JUNE 5, 2020

Mail out of absentee ballots will begin on **April 21, 2020** and end on **June 5, 2020**. A request for an absentee ballot may be submitted by mail, email, fax or you may complete the application in person at our office. You must file a separate application for each election and run-off election for which you are requesting an absentee ballot; **except if you are a voter who is over the age of 65, disabled, a military service member or spouse of a service member, or an overseas citizen (temporary or permanent)**. Call Chatham County Voter Registration at **(912) 790 -1520** for further details. **Absentee request forms can be accepted 180 days prior to an election.**

EARLY IN-PERSON VOTING:

MAY 18, 2020 – JUNE 5, 2020

Early in-person voting is available 21 days prior to the election. Any eligible registered Chatham County voter desiring to vote in advance during this period may do so in-person. No reason is required.
